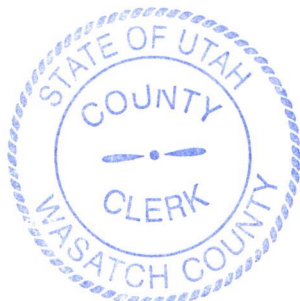

## QUALIFICATIONS

Before the filing officer accepts any declaration of candidacy, the filing officer shall read to the candidate the constitutional and statutory requirements for candidacy, and the candidate shall state whether he/she fulfills the requirements. If the candidate indicates that he/she does not qualify, the filing officer may not accept his/her declaration of candidacy (Utah Code Section 20A-9-201, 202).

### Wasatch County Council

Utah Code 17-16-1; 20A-2-101-5; 20A-9-201; 20A-9-202

- U.S. Citizen
- Registered voter for at least one year before the date of the election
- Be registered voter of the county which the member represents
- If convicted of a felony All felony convictions have been expunged; ten years have passed, and all court ordered fines and penalties have been paid; probation is completed; parole has been granted; term of incarceration is completed
- Pay filing fee of \$249.28

### County Clerk, Auditor, Recorder, Treasurer

Utah Code 17-16-1

- A registered voter in the county.
- At least a one year resident of the county immediately before the date of the election.
- Pay filing fee of \$653.88

## UTAH CANDIDATE FILING QUALIFICATIONS

### QUALIFICATIONS

Before the filing officer accepts any declaration of candidacy, the filing officer shall read to the candidate the constitutional and statutory requirements for candidacy, and the candidate shall state whether he/she fulfills the requirements. If the candidate indicates that he/she does not qualify, the filing officer shall decline his/her declaration of candidacy. (Utah Code Section 20A-9-201, 202)

#### All must be a U.S. Citizen

#### County Commission/Council *(17-53-201, 17-16-1)*

- Registered voter of the County for at least one year immediately preceding the election.
- At least one year resident and Maintain residency in County.

#### County Clerk, Auditor, Recorder, Treasurer *(17-16-1)*

- Registered voter of the County for at least one year immediately preceding the election.
- At least one year resident and Maintain residency in County.

#### County Assessor *(17-17-2, 17-16-1)*

- Registered voter of the County for at least one year immediately preceding the election.
- At least one year resident and Maintain residency in County.
- State-registered appraiser within 36 months from the day in which term of office begins.

#### County Surveyor *(17-16-1)*

- Registered voter of the County for at least one year immediately preceding the election.
- At least one year resident and Maintain residency in County.
- Shall be a state-registered appraiser within 36 months from the day in which the term of office begins.

#### County Sheriff *(17-22-1.5, 17-16-1)*

- Registered voter of the County for at least one year immediately preceding the election.
- At least one year resident and Maintain residency in County.
- At time of filing; has successfully met the requirements of the Peace Officer Training and Certification Act; or has passed a certification examination and be qualified to be certified as defined in Section 53-6-103.
- Certified as a law enforcement officer and correctional officer as defined by 53-13-103 and 104.

#### County Attorney *(17-16-1, 17-18-5)*

- Registered voter of the County for at least one year immediately preceding the election.
- At least one year resident and Maintain residency in County.
- An attorney licensed to practice law in Utah who is an active member in good standing of the Utah State Bar.

#### District Attorney *(17-16-1, 17-18-5)*

- Licensed to practice law in Utah who is an active member in good standing of the Utah State Bar.
- Registered voter in a county or prosecution district in which he/she is seeking office.
- Current resident, and resident for at least one year, of the prosecution district in which he/she is seeking office and maintain residency in district.

\* A qualified voter (1) is a citizen of the United States; (2) is a resident of Utah; (3) will, on the date of that election: be at least 18 years old, and have been a resident of Utah for 30 days immediately before that election; 4) and has registered to vote.

# PLEDGE OF FAIR CAMPAIGN PRACTICES

(Utah Code §20A-9-206)

There are basic principles of decency, honesty, and fair play which every candidate for public office in the State of Utah has a moral obligation to observe and uphold, in order that, after vigorously contested but fairly conducted campaigns, our citizens may exercise their right to a free election, and that the will of the people may be fully and clearly expressed on the issues.

## THEREFORE:

**I SHALL** conduct my campaign openly and publicly, discussing the issues as I see them, presenting my record and policies with sincerity and frankness, and criticizing, without fear or favor, the record and policies of my opponents that I believe merit criticism.

**I SHALL NOT** use, nor shall I permit the use of, scurrilous attacks on any candidate or the candidate's immediate family. I shall not participate in or nor shall I permit the use of defamation, libel, or slander against any candidate or the candidate's immediate family. I shall not participate in nor shall I permit the use of any other criticism of any candidate or the candidate's immediate family that I do not believe to be truthful, provable, and relevant to my campaign.

**I SHALL NOT** use, nor shall I permit the use of, any practice that tends to corrupt or undermine our American system of free elections, or that hinders or prevents the free expression of the will of the voters, including practices intended to hinder or prevent any eligible person from registering to vote or voting.

**I SHALL NOT** coerce election help or campaign contributions for myself or for any other candidate from my employees or volunteers.

**I SHALL** immediately and publicly repudiate support deriving from any individual or group which resorts, on behalf of my candidacy or in opposition to that of an opponent, to methods in violation of the letter or spirit of this pledge. I shall accept responsibility to take firm action against any subordinate who violates any provision of this pledge or the laws governing elections.

**I SHALL** defend and uphold the right of every qualified American voter to full and equal participation in the electoral process.

**I**, the undersigned, candidate for election to public office in the State of Utah, hereby voluntarily endorse, subscribe to, and solemnly pledge myself to conduct my campaign in accordance with the above principles and practices.
