Being duly subscribed to and sworn I hereby state under oath and subject to prosecution for perjury:

1. I am the above named defendant.
2. As part of my sentence the court has required me to have an Ignition Interlock Device on any vehicle I operate during the term of my probation.
3. Subject to a prosecution for perjury I hereby state that I

\_\_\_\_\_ (initial one) Have or have access to a vehicle and I understand I am required to have an interlock device installed within 10 days and continually during the term of my probation and the Utah Driver's License Division may require a longer period.

\_\_\_\_\_ (initial one) Do not have an operable vehicle available to me, registered **or** titled in my name **and** that I am not currently operating **any** vehicle.

4. I understand and agree to have an Ignition Interlock installed on any vehicle that I operate during probation whether or not it is my vehicle. This includes vehicles belonging to friends, family or employers.

5. I understand that should I be found operating a vehicle during the term of my probation that does not have a functioning ignition interlock installed that I will be charged with operating a vehicle without an ignition interlock which is a Class B Misdemeanor punishable by up to SIX months in jail and fines of up to almost **\$2,000.00** plus an additional **ONE** year suspension of my driver's license.

6. In addition to the new charge of operating without an ignition interlock device it will be a violation of my probation and I will be required to appear before Judge Sessions for the entry of sanctions which may include jail, an increased fine and an extension of my probation.

7. I agree that if I purchase a vehicle, borrow a vehicle, register a vehicle in my name, fix a vehicle I am on title to or if I am put on title to any vehicle I will notify this court with five days of said event.

8. I agree not to operate any vehicle unless I have a valid driver's license. If I do, I understand this will be a violation of the terms of my probation and result in additional sanctions in this case as well as new charges and an extension of my driver's license suspension period.
