Open Space Bond approved in 2018 for \$10 million. County Council bonded for \$5 million in September 2020. *Totals calculated for last two columns:*

*Heber City is spending an additional \$2+ Million for Muirfield Nature Park improvements on easement property, etc. This was a full land purchase for public use as defined per County Code.

**Lundin Farm project is counted here as an approved project, though it is NOT funded yet because Council conditions related to County code conservation values still need to be met.
